THIS FISCAL YEAR, SUPPORT DOGS PLACED 19 NEW ASSISTANCE DOG TEAMS WITH INDIVIDUALS HAVING VARIOUS DISABILITIES. IN ADDITION, SUPPORT DOGS RECERTIFIED 81 CURRENT TEAMS.
