ONCE TRAINED, THE DOGS CAN ASSIST WITH MOBILITY AND HEARING RELATED TASKS SUCH AS RETRIEVING ITEMS AND ALERTING TO SOUNDS. A FACILITY DOG IS TRAINED AND PLACED WITH AN INDIVIDUAL WHO IS AN EMPLOYEE OF A FACILITY THAT WORKS WITH AT RISK POPULATIONS. TYPICALLY, THE DOG IS USED AS A THERAPEUTIC TOOL BY THE HANDLER, HELPING TO INITIATE A RESPONSE FROM THE RESIDENTS, PATIENTS, OR CLIENTS OF THE FACILITY.
